



In response to Society's advertisement dated 16<sup>th</sup> September, 2022 you had applied for **CHB** post of **Assistant Professor (Lecturer) of English**. You were interviewed for the above post by the Local Selection Committee (Walk-in-interview) appointed by the Management under Statute No. 415 of the Savitribai Phule Pune University.

This is to inform you that as recommended by the Local Selection Committee the Management has appointed you on **CHB** post in Society's **RNC Arts, JDB Commerce & NSC Science College, Nasik Road (Grant-in-aid)** with effect from **27<sup>th</sup> September, 2022 upto the end of Academic Year 2022-23** or till regular University Selection Committee meeting held, whichever is earlier subject to the following terms and conditions.

- 1: This post is **Clock Hour Basis Post**.
- 2: The remuneration for the appointment shall be the remuneration prescribed, approved and sanctioned by the Government for the concerned post and said remuneration as per Government sanction shall be paid only after approval of your appointment by the competent authority for the post.


