## 1. EXECUTIVE SUMMARY

#### 1.1 INTRODUCTION

RNC Arts, JDB Commerce and NSC Science College, established in June 1963 by the Gokhale Education Society, has a rich history in Nashik Road. Located conveniently near Bytco Point, a central hub, the College is also well-connected, lying just 2 kilometers from the Nashik-Road Railway Station. The sprawling campus encompasses a significant 18.5 acres, with a substantial built-up area exceeding 8433.514 square meters.

The College started with a strong foundation in three core streams: Arts, Commerce, and Science. Over time, it has flourished, introducing post-graduate programs and specialized self-financed courses catering to in-demand fields like Biotechnology, Business Administration, Computer Science, and even a Master of Science in Organic Chemistry. This dedication to keeping pace with industry demands is commendable.

The leadership of Principal Dr. Manjusha Kulkarni is instrumental in the College success. The College has twice been recognized for its excellence, prestigious Prin. T.A. Kulkarni Five Star Quality and Excellence Award was conferred upon the College by the Gokhale Education Society in 2009 and 2013, highlighting its commitment to providing a superior educational experience. This year again the College has been awarded, "Best College of the year 2023-24, by Gokhale Education Society. Exceptional efforts taken by College, in promoting voter awareness and registration have been recognized by the Maharashtra State Election Commission. We are proud to announce that College has been awarded the "Best College 2024" honored by the Election Commission.

On an average, over 3820 students have enrolled annually for the past five years. A significant portion of the student body comes from economically disadvantaged backgrounds. Many students hail from nearby rural areas. The College recognizes the importance of education for all, and it plays a vital role in providing these students with the opportunity to excel through quality education. Thus, College stands out not just for its academics but also for its dedication to social responsibility.

By making education accessible to students from weaker sections, College empowers them to break free from the cycle of poverty and achieve their full potential. This focus on social mobility creates a diverse and enriching learning environment for all students.

#### Vision

The College is propelled by a visionary management which has well-defined goals and perspective plans for its developmental work. A perspective plan which includes short-term and long-term goals in various aspects of the functioning of the College such as curricular aspects, teaching, learning and continuous evaluation, innovation, research and extensions, infrastructure, academic and physical facilities, student support and progression is designed. To implement these plans effectively, adequate measures are taken to mobilize resources. The IQAC oversees and guides the preparation of perspective plans and policies based on the quality policy and activities proposed by various departments for the academic calendar.

## 1.2 Strength, Weakness, Opportunity and Challenges(SWOC)

#### **Institutional Strength**

- College was established in 1963, as a multi faculty educational institution with Arts, Commerce and Science.
- It provides both, grant-in-aid undergraduate (UG) and postgraduate (PG) programs. Additionally, there are self-financed UG and PG programs in Computer Science, Biotechnology, Business Administration, and Organic Chemistry.
- College is located in prime location which is easily accessible by general public and easily approachable by roadways and railways.
- College is ISO 9001:2015 Quality Management System certified since the year 2003. The management is committed to foreseeing future requirements and meeting them through creative, value-based, high quality education.
- Our faculty is well qualified, dedicated and sensitive to the needs of our students and specially committed to offering a very democratic learning environment.
- College has inculcated a research culture among the faculty members and students as well. More than 45% of the teaching staff are awarded with Ph. D. degree.
- College offers practical based courses and subjects with various options for UG and PG students. Along with academic programs the College has developed excellent ties with the social and business organizations, NGOs in and around the Nashik city and rural region.
- For the overall development of students, our College has established various forums which includes NSS, NCC (Air wing), NCC (Army wing), Student Council Cell, Student Development Cell, Vidyarthini Manch, and Youth Empowerment Cell.
- The Career Counseling cum Placement Cell gives guidance to the students for pursuing future career.
- The College actively organizes various environmental awareness programs, promoting sustainability among students.
- The College boasts well-equipped science laboratories and infrastructure. Additionally, it provides computer labs, sports facilities, a seminar hall, a commerce lab, and a library with e-books accessible to both faculty and students.
- The College fosters a healthy and positive atmosphere for both students and staff members.
- The presence of public support services like banks and a police station on campus provides added convenience and security for students and staff.
- Twelve staff members have registered patent rights, showcasing the College's commitment to research and innovation.

#### **Institutional Weakness**

#### **Infrastructure Challenges:**

• The College faces increasing commercialization and overcrowding in the surrounding areas, potentially

- impacting the learning environment.
- The growing student body necessitates additional classrooms and laboratories to maintain adequate learning space.
- Currently, seven classrooms are equipped with Information and Communication Technologies (ICT), which is insufficient for the entire student population.

#### **Research Limitations:**

• Limited funding from the University Grants Commission (UGC) and other research bodies restricts opportunities for faculty and students to undertake research projects.

#### **Missing Amenities:**

• The College does not have a specific cafeteria service, which can be very inconvenient for students, especially those who are spending long hours on campus.

#### **Institutional Opportunity**

- The curriculum of the College will undergo revision to highlight the NEP-2020, with a focus on engaging in collaborative activities with Academia and Industry.
- To enhance learning, the college aims to introduce project based activities and Industry exposure through internships and visits.
- The college aims to conduct training session to equip faculty with NEP-2020 pedagogy, technology integration skills and knowledge of industry trends.
- For professional and academic development of faculty members, the college would strengthen interinstitutional tie-ups and Memorandum of understanding (MOUs) with Industries, Corporate sectors and Social organizations
- Initiatives promoting waste management, water conservation, sustainable landscaping, will be implemented for greener campus.
- To strengthen Industry connect, the college aims to develop a strong alumni network.

#### **Institutional Challenge**

- Though existing infrastructure is adequate, there is a room for improvement and expansion.
- Amidst this technological revolution, deterring students from using mobile phones for non-educational purpose is a challenge. A greater challenge is to encourage students to leverage mobile phones for learning.
- Fostering a strong research culture among students.
- The college has to compete with many universities offering distance education programs.
- The college also faces a challenge of increasing the number of placements and securing higher annual packages for students

#### 1.3 CRITERIA WISE SUMMARY

#### **Curricular Aspects**

The College offers a diverse array of academic streams, encompassing Arts, Commerce, and Science. It provides both grant-in-aid undergraduate (UG) and postgraduate (PG) programs. Additionally, there are self-financed UG and PG programs in Computer Science, Biotechnology, Business Administration, and Organic Chemistry. The College has adopted a Choice-Based Credit System for all UG and PG programs, aligning with the guidelines set by Savitribai Phule Pune University, Pune.

Two faculty members serve as Members of Board of Studies Savitribai Phule Pune University, Pune. The College has introduced three add-on courses and seven certificate courses, with a strong focus on developing skills relevant to entrepreneurship and employability. To foster a research-oriented culture among students, the College houses M.Phil. and Ph.D. research centre in Commerce and has applied for new research centres in English, History, and Marathi in the current year.

A well-structured mechanism ensures timely curriculum delivery. Faculty members utilize ICT tools and the latest digital platforms for teaching-learning. Practical sessions, field visits, project work, assignments, educational tours, and exhibitions provide valuable feedback during continuous internal evaluation. The College has well-equipped science experimental laboratories to facilitate experimental learning. The resourceful library enriches both faculty and students. The institution promotes overall personality development, offering equal opportunities regardless of caste, class, or gender. Students engage in various academic, curricular, extracurricular, cultural, and sports activities, contributing to atmosphere of healthy competition.

The College has a transparent, objective based feedback system. Each year, systematic feedback is collected from Students, Teachers, Alumni and Employers for effective teaching and learning process.

#### **Teaching-learning and Evaluation**

Ensuring quality education is vital for the growth of any educational institution, our College prioritizes transparent admission processes following the guidelines of Savitribai Phule Pune University and the Government of Maharashtra. Our Admission Committee oversees this process, providing counselling to students for a smooth admission experience.

Over five years, our enrollment rate averaged 77%, with 88% of reserved seats filled, promoting inclusivity. Maintaining an optimal student-teacher ratio of 38:1, we have 100 teaching faculty, including 46 granted and 54 non-grant full-time staff. 45 teachers have completed their Ph.D., while others are in the process. Furthermore, 34 faculty members have cleared exams like SET/NET/GATE.

Our institution features a robust evaluation system, overseen by the Examination Committee, ensuring fairness and transparency. We adhere to the Choice Based Credit System and SPPU guidelines for evaluation.

To foster engaging learning experiences, our teachers employ interactive and innovative methods of teaching. We emphasize ICT-based learning, encourage participation in co-curricular and extracurricular activities, and organize various competitions and events like poster making, essay writing, poetry reading, seminars, elocution competition etc.

Evaluation methods include seminars, projects, oral tests, assignments, and tutorials. Result analysis is conducted, and remedial measures are implemented, including extra classes and doubt clearing sessions for academically weaker students.

To enhance student performance and learning outcomes, each department organizes introductory sessions with students to discuss program outcomes and course objectives. These details are also available on the institution's website for easy reference. Teachers actively participate to ensure the successful implementation of these programs.

#### Research, Innovations and Extension

The College has strengthened the research activities and enrich the research output by rendering support in the form of financial, academic and human resources. The creation and promotion of a research-friendly environment are facilitated by the Academic Research Committee (ARC), Internal Quality Assurance Cell (IQAC), and Research Policies. The College have two research centers, 23 research guides, 17 enrolled research scholars. The faculty has successfully concluded two funded research projects, secured 02 research travel grants, and obtained one endowment with a grant of 8.57 lakhs. The College actively promotes, assists, and guides students in participating in the innovative AVISHKAR competition, providing them with a plgranted 12 patents by the Government of India. The Institution has created an Ecosystem for innovation such as Incubation centre and conducted 7 workshop/seminars on Intellectual Property Rights and research methodology. The faculty members have published 184 articles in journals and 81 chapters/books. The institute actively encourages stakeholders for holistic development and raises awareness about social issues through extension and outreach activities. The Institute has been honoured with 05 awards from governmental and nongovernmental organizations for its extension and outreach activities. The College has conducted 59 extension activities aimed at social upliftment by NCC, NSS, SWD, and other support services in which maximum number of students have actively participated. The College has established collaborations and linkages with 15 organizations, with 11 Memoranda of Understanding (MoUs) signed.

#### **Infrastructure and Learning Resources**

The College is fully equipped to support the teaching and learning experience. Covering a total area of 18.5 acres, the campus comprises 37 classrooms, 18 laboratories, 2 seminar halls, an Open Auditorium, and a NAAC Room. The College has seven classrooms equipped with ICT facilities to enhance the learning environment. The College provides ample infrastructure for both indoor and outdoor sports activities, with a well-maintained playground spanning an area of 20698 square meters for practice and hosting sports tournaments. Furthermore, students have access to green gym and multi-gym facilities for their fitness needs.

The College has a seminar hall equipped with good audiovisual facilities. Also, there is an Open Auditorium and an Assembly hall available on campus. These facilities are utilized for arranging various events including conferences, seminars, workshops, placement activities, and cultural events, providing a versatile space for academic and extracurricular activities alike. The college campus features a meticulously maintained botanical garden, offering students and faculty academic friendly environment. The college has sufficient parking space for four and two-wheelers, ensuring convenient access. Safety and security are prioritized, with continuous CCTV surveillance and round-the-clock security personnel stationed throughout the campus. The College library occupies 7000 square feet in built-up area. It possesses a substantial collection of 98,206 books, catering comprehensively to the academic requirements of students and faculty members. The College is equipped with a total of 156 computers, out of which 142 computers allocated for student use. All computers are interconnected via a local area network (LAN) and have internet access. The institute utilizes a 2 Mbps and 10 Mbps leased line to provide internet connectivity through the LAN. In terms of software, the institute offers a range of programming tools and environments, including Python, R software, R-Studio, Visual Studio 2010, Java, PHP and SQL Server 2008, enabling students to develop their skills across various programming

languages and platforms.

#### **Student Support and Progression**

RNC Arts, JDB Commerce and NSC Science College emphasizes holistic student development, facilitated through co-curricular and extra-curricular activities. We recognize our responsibility to our students' future; may it be further education or employment or entrepreneurship. The orientation and support for it is facilitated through expert talks, seminars on career opportunities, awareness initiatives in research and innovation, health awareness programs, skill development and ICT workshops, and social service events. Additionally, guidance for competitive exams like SET/NET has seen an increase in qualifying students. The College promotes physical and mental well-being through sports (football, basketball, etc.) and cultural celebrations (Ganesh festival). These initiatives contribute to a holistic personality development that benefits personal and professional lives. Campus placement drives organized annually by the College served as a valuable platform for students to explore opportunities across diverse industries. Scholarship support is provided to students, with an annual average of more than 40% benefiting from government scholarships. Students from EBC, OBC, SBC, VJNT and minority community have particularly benefited from this support. College upholds a safe and supportive environment, guided by UGC and Savitribai Phule Pune University. Committees including SGRC, Anti-Ragging, and Internal Complaints Committee (ICC) maintain discipline and address grievances. 'Annual Fest' is our unique annual event celebrated once a year with huge participation of students in various events organized during the fest. Our students have proven the efficacy of these initiatives by winning many awards in these events. We strongly believe in raising individual who are proficient in their field of expertise, achieve success and contribute positively to society.

#### Governance, Leadership and Management

#### **CDC**

The College Development Committee works as an interface between the College and the managing board to review the functioning and make decisions for the future growth of the College.

#### **Administrative setup:**

The Management, Principal, Vice-Principals, HOD, and faculty members implement plans for academic development.

## Institutional preparedness for NEP

The Electoral Literacy Club, led by Principal Prof. Dr. Manjusha Kulkarni, Dr. Sudhakar Borase as the Nodal Officer, Rajkumar Kanojiya as Chairman, and Miss. Saroj Kambale as Vice-Chairperson, along with 19 active student members, was established by the College. The Electoral Literacy Club (ELC) is indeed functional. The students' coordinator and coordinating faculty members are appointed by the College, for smooth functioning of ELC. Members of the ELC are chosen from various classes and act as representatives for their fellow students. The ELC functions by organizing various activities aimed at

enhancing electoral literacy among students. These activities range from awareness campaigns to interactive sessions, all geared towards fostering a deeper understanding of the electoral process among the students.

3. What innovative programmes and initiatives undertaken by the ELCs? These may include voluntary contribution by the students in electoral processes-participation in voter registration of students and communities where they come from, assisting district election administration in conduct of poll, voter awareness campaigns, promotion of ethical voting, enhancing participation of the under privileged sections of society especially transgender, commercial sex workers, disabled persons, senior citizens, etc.

The Electoral Literacy Club (ELC) has initiated a range of innovative programs and projects with the aim of encouraging electoral engagement and awareness among students. These endeavors involve voluntary student contributions to electoral procedures, such as aiding in voter registration campaigns for both student bodies and the wider community they represent. These initiatives include voluntary contributions by students in electoral processes, such as assisting in voter registration drives for students and communities they belong to. The ELC members actively engage with District Election Administration to facilitate the smooth conduct of polls. Additionally, they organize voter awareness campaigns to educate people about their voting rights and responsibilities. These campaigns also emphasize the importance of ethical voting practices. Furthermore, the ELC work towards enhancing the participation of underprivileged sections of the society. Through these initiatives, the ELC strive to foster a culture of informed and inclusive democracy within both the students and the community.

4. Any socially relevant projects/initiatives taken by College in electoral related issues especially research projects, surveys, awareness drives, creating content, publications highlighting their contribution to advancing democratic values and participation in electoral processes, etc.

Electoral Literacy Club has taken efforts towards voter registration and awareness campaigns. These included poster making, quiz competition, daily notice readings in classrooms, street plays, guest lectures, WhatsApp messages, essay competitions, rangoli competitions, voter awareness rallies, and various other social events. Apart from diligent efforts through these mediums, outreach was extended to relatives, friends, and the community. This resulted in achieving a 100% voter registration target. The Nodal Officer Dr. Sudhakar Borse guided to all Presiding Officers (PRO) appointed by Election Commission of Maharashtra for Loksabha Election 2024. The culmination of these efforts bore fruit as six colleges across Maharashtra were selected for their outstanding and innovative work related to electoral literacy during the 2023-24 period. Among them, our College was honored with the "Best College Award 2024" by the Chief Electoral Officer

of Maharashtra on January 24, 2024, in Mumbai on occasion of the National Voter's Day. The recognition was bestowed upon the College's Principal, Nodal officer, and student representatives for their exemplary leadership in organizing voter awareness initiatives.

5. Extent of students above 18 years who are yet to be enrolled as voters in the electoral roll and efforts by ELCs as well as efforts by the College to institutionalize mechanisms to register eligible students as voters.

This year the total number of 2561 students above 18 years have been enrolled as voters in the electoral roll. To achieve this, Electoral Literacy Club (ELC) has been instrumental in raising awareness among students about their voting rights and the importance of participating in the electoral process. ELC conducted awareness campaigns, organizes voter registration drive, and provides resources to guide students through the registration process. By engaging directly with students in a peer-to-peer manner, ELC played a crucial role in encouraging young voters to exercise their votes. The College has instituted mechanisms for voter registration collaborating with local election authorities to set up registration booths on campus, incorporating voter registration drives along with orientation programs and integrating voter education modules into the curriculum. By institutionalizing these efforts, College not only fulfils its civic responsibilities but also empower students to become active participants in the democratic process. Through sustained initiatives aimed at increasing voter registration among eligible students, ELC as well as College contributes in building a more inclusive and participatory democracy.

#### **Response:**

Once admitted, students undergo continuous assessment through various methods at both College and University levels. Timetables of internal exams are displayed and communicated to students beforehand through WhatsApp groups. The Principal conducts faculty meetings to ensure effective implementation of the evaluation process. The College has established a comprehensive evaluation system that emphasizes consistency and variety, incorporating continuous assessment techniques like Group Discussions, Unit Tests, Assignment Submissions, Field Visits, and Seminar Presentations, to ensure transparency and efficacy. Unit tests are conducted regularly as per the academic calendar, with varying weightage determined by the faculty. Students' performance is openly displayed and communicated, with personalized guidance provided to those who perform poorly. Second and third-year students are required to deliver seminars on their subjects, with topics provided by their teachers for PowerPoint presentations.

To ensure transparency and robustness in internal assessment, the following mechanisms are implemented:

Science College, Nasik-road, there are well established systems, procedures for maintaining and utilizing support facilities such as computer laboratory, library, gymkhana, computer, classrooms etc. The College has adequate physical and academic facilities required as per the UGC guidelines to run different academic programs smoothly. The total campus area is of 18.5 acres and college built up area is 8433.514 sq.mt.College has appointed staff for the maintenance of physical, academic, support facilities. They help to keep the equipment, machines in working condition. For ensuring security, the College has installed CCTV at various places within the building.

The following are the details of the maintenance and utilization of the facilities:

## Classrooms:

There are 37 classrooms fully-furnished, well ventilated, spacious lecture rooms for conducting theory classes. Now 07 classrooms are furnished with LCD projector and internet facility to adopt to advanced teaching methods.

### Laboratories

Institute has 18 laboratories to carry out the science experiments and projects.

# Computing equipment

There are total 156 computers (150 computers and 6 laptops). Out of which, 142 computers are made available to students. All the computers are connected with local area network and internet facility. The institute has 2 MBPS and 10 MBPS lease lines for the internet facility through LAN. The institute has softwares like Python, R and R- Studio, Visual Studio 2010, Java, PHP, SQL Server 2008. In addition to the regular activities students can download research papers, browse internet, prepare report, power point presentation etc.

# Facilities for Cultural activities:

A Seminar hall with good audio visual facility is provided. This seminar hall has seating capacity of 200

Our College library is named after its donor Shri. "BALARAM HEMRAJ LAHOTI LIBRARY" and was established in the year 1963 and it supports the academic and extra-curricular activities of the College. The library is situated in a separate two-storied building with a built-up area of 7000 sq. ft. The ground floor houses the Books Stack Area, Circulation Counter, Online Public Access Catalogue (OPAC), Network Resource Centre, Journals and Periodicals section, and Administration Section. The first floor houses, Reading Hall, Reference Section, Periodical section, and Hindi and Commerce Research Centre. The library has a strong collection of books in various subjects. The library holding consists of Text Books, Reference Books, General Books, Journals, Bound Volumes of Periodicals, CDs, and some rare Books. Our library also has a collection of some unique and rare books which contributes in ancient Indian Knowledge System. The library has separate section of competitive examination books to encourage students to prepare for competitive examination. Total 7060 books purchased during the last five years 2018-19 to 2022-23 and subscribed to 66 journals. The college library has subscribed to e-books and e-journals through N-LIST from INFLIBNET. The library has a collection of 98,206 books (as on dated 31/12/2023) on various subjects with adequate number of reference books and serves the information needs of the staff and students of the College by providing access to information in all formats. Library provides Open Access facility to all students and staff to browse the library collection. The reading room facility is available to the students from 09:00 a.m. to 04:40 p.m. on all working days.

The library has inter-library borrowing facility with Yaswantrao Chavan Maharashtra Open University, Nashik, Government Divisional Library, Nashik Road, Nashik and our G.E. Society's college's library. Library has membership of Dosti House, Mumbai (The American Library, Mumbai) and Government Divisional Library, Nashik Road, Nashik. To promote reading habits among students and staff, the library organized book exhibitions.

Library services are partially computerized. The College has installed 'Library Manager', software for housekeeping operations. Following services are computerized: Acquisition procedures of library books, Book transaction/circulation, various types of reports are generated automatically, Overdue charges, Online Public Access Catalogue (OPAC). We provide Internet facility to the users during working hours. Library provides a book bank facility to needy Students. College continuously reviewed and upgraded the facilities including software, hardwares, internet connectivity, backup, and allied IT facilities to ensure better learning experiences.

HEI' has dedicated IT staff to cater to the need related to IT infrastructure and maintenance. Over the years, the institute has made several purchases to upgrade its software and hardware capabilities like number of computers, laptops, software, printers, scanners, LCD projectors, Xerox machines, internet, etc.

An agency, Hi-tech computers Service (N) Pvt. Ltd has been appointed to upkeep all IT and related

facilities for efficient functioning of academic and administrative activities. The institute places a strong emphasis on keeping its IT facilities up-to-date and ensuring that there is sufficient bandwidth available for users.

The systems are connected with local area network, in that there are two BSNL lease lines with 2MBPS and 10MBPS speed. The institute pays and updates the BSNL lease line connections on yearly basis. All the computers are connected with LAN

The institute has softwares like Python R and R Studio, Visual Studio 2010, Java, PHP, SQL Server 2008. The College has three computer labs for UG students, ICT enabled seminar hall. The College library is partially automated with Library Manager 2.0 software. Library also subscribes to e-books, e-shodhsindhu, e journals through N-List and open access sources. All the academic departments and administrative sections are equipped IT facilities for stakeholders. Most of the departments have Computers, Printers and LCD projectors. College has six dedicated servers for the smooth functioning of the office, library and computer science laboratories. College has Biometric access control for the teaching and non-teaching staff.

In 2018-19 the institution has acquired 40 Lenovo desktop Intel core 2D40 processor, Intel chipset mother board 4GB RAM.320GB hard disk drive Monitor cabinet DVD ROM for its Computer Science lab.

# 6.4 Financial Management and Resource Mobilization

- The payment vouchers are verified by the Accountant, signed by the Principal and authorized Management signatories.

The initiative to incorporate digital technology in classrooms gained momentum through the IQAC (Internal Quality Assurance Cell). Collaborating with the parent society, the IQAC organized a large-scale online MDP (Management Development Program) for faculty members, upskilling them in digital technology. Faculty members were oriented to software tools like Screencastify and OBS, enabling them to create digital modules for students. They were also sensitized to recording, sound, and video editing techniques. Subsequently, 42 faculty members received promotions and support from the IQAC to undergo training programs in MOOCs (Massive Open Online Courses) development and digital literacy. They designed their own digital modules and utilized online platforms to deliver classes.

Some faculty members were even invited by external organizations, such as MHRD's SWAYAM platform, to design teaching and learning modules. The IQAC actively oversaw their progress and monitored the digital platforms they engaged with. Digitally equipped classrooms transformed the teaching-learning process, providing a whole new dimension. Students benefited significantly from this exposure, accessing lectures and programs like soft skill development online. Additionally, they received updated information on assignments, practicals, and internal exam schedules displayed digitally.

# **Industry-Academia Linkage**

The IQAC has been invested in devising ways to increase opportunities of industry exposure for its students. This is because it believes that a professional workplace enables students to acquire hard and soft skills required by the industry. With this objective, the IQAC has been focusing on initiating and sustaining the MOUs with the industry and other organisations from the banking and financial sector. As part of the terms and conditions mentioned in the MOU, students undertake frequent and regular site visits where they get hands-on experience of that particular field. Experts from the concerned sector come to the College and deliver guest lectures and guide student seminars. The IQAC has been dedicated to maintaining student participation and enrolment in certificate courses which gives them additional knowledge, expertise and experiential training and makes them more industry-ready.

Besides this the IQAC has been majorly instrumental in organizing institutional level training programmes for faculty members and programmes focusing on citizenship, social outreach and community development and environmental awareness for students.
